DESCRIPTION

User Print Management provides an end-user interface to control and query printers and print jobs in a SCO UNIX® system environment. The product is part of the DECadvantage Product Set.

The end-user interface is menu based. The product is based on the UNIX Spool System (UNIX Version 3.2 Print Service) as supported by SCO[™] UNIX System V /[™]386, Release 3.2, and can be executed from the console, or from every terminal connected to the system. The user interface hides all intricacies of the command line interfaces available in standard UNIX (UNIX Version 3.2 Print Service).

The following functions are offered:

- show all print jobs of all users or of a specific user
- · show all print jobs for a specific printer
- show detailed print job information
- modify a print job
- cancel a print job
- · move a print job to the head of the queue
- move a print job to another printer or class
- show detailed printer or class information
- · show the printers belonging to a class
- · show the print jobs queued for a printer or class
- show all printers and classes
- · assign a new default printer
- move all print jobs queued for a printer or class to another printer or class
- allow/prohibit a printer or class to accept print jobs (accept/reject)
- allow/prohibit a printer to print print jobs (enable /disable)
- inform the system that a new form has been mounted on a printer

- allow a print job to continue after paper adjustment actions
- repeat print of an adjustment page to allow further paper adjustment
- · show the print system alert messages
- remove an alert message
- show all retained print jobs of all users or of a specific user
- show all retained print jobs for all printers or for a specific printer
- · show detailed retained print job information
- print a retained print job
- · remove a retained print job

This product offers a number of functional extensions to the UNIX Print Service. These are:

- a retain option, storing the print job for a specified or default time after the job has been printed. This allows simple recovery from printer and print system malfunctioning.
- printing of a subset of the pages of a print job.
- printing of an adjustment page (forms printing) with content derived from the print job.
