#### DESCRIPTION

Compag DECset Clients for CMS and MMS provides access from the desktop personal computer (PC) to the Compaq Code Management System (CMS) libraries and Compaq Module Management System (MMS) features residing on OpenVMS Alpha and OpenVMS VAX systems. CMS, a component of the Compaq DECset software development tools, is an online library system that helps track software development and maintenance. MMS, a component of the Compag DECset software development tools, is a software system builder that simplifies the building of applications. MMS optimizes the build process by tracking the complex dependencies and relationships that exist between software components. (For more information on CMS or MMS for OpenVMS VAX systems refer to SPD 27.07.xx. For more information on CMS or MMS for OpenVMS Alpha systems refer to SPD 42.29.xx.)

DECset Clients for CMS and MMS can be used from a personal computer running Microsoft Windows 2000, Windows 98, Windows 95, or Windows NT. Connection to a CMS library or MMS feature from the PC is possible once the Server software (provided with the Client) and the CMS and MMS for OpenVMS software are installed at the server site.

The main DECset Clients windows offer menu access to most of the CMS and MMS functions. DECset Clients commands can also be performed by clicking the command buttons on the toolbar. In addition, DECset Clients supports drag-and-drop functionality for manipulating data within the DECset Clients window.

Developers have two new methods to interact with CMS Client. Developers can now access CMS Client features directly from Microsoft's Visual Studio and an API is available to provide users with a convenient method to write their own Microsoft Visual C++ applications to gain access to CMS on OpenVMS Systems. Users can stay within their development environment and interact with their OpenVMS CMS libraries.

# Features

# CMS Client

Access to CMS Client features is through three means: a graphical user interface (GUI), an application programmer interface (API), or Microsoft's Visual Studio.

GUI or API:

- Access a CMS library on an OpenVMS server system.
- Change the working (local) directory.
- Create an element, class, or group.
- · Delete a specified class from a CMS library.
- Delete an element from a CMS library.
- · Delete one or more element generations.
- Delete a specified group from a CMS library.
- · Merge elements.
- Support for variant generations.
- Fetch or reserve a copy of an element generation from a CMS library and place it in the current local PC directory.
- Insert or remove an element or group into or from a specified group.
- Insert or remove a specified element generation into or from a class.

#### **Compaq DECset Clients for CMS and MMS Version 2.1**

- Replace the latest version of a modified file into a CMS library.
- Store PC files in CMS on the OpenVMS system.
- Set or change a password to control use of the CMS Client.
- Cancel an existing reservation of an element generation (Unreserve).
- Display the name and contents of groups and classes in a CMS library.
- Display a chronological list of transactions performed on a CMS library.
- Display information about current reservations and concurrent replacements.
- Display differences between local files.

#### Microsoft Visual Studio:

- Place projects under source code control on an OpenVMS server.
- Add and remove files in a project from source code control.
- Get latest version, (fetch), checkout and checkin files under source code control.
- · Add files to a project from existing CMS libraries.
- Show differences, display differences between the local file and the file under source code control.
- Show history, display source code control history of files.
- Invoke the CMS Client tool for administrative operations.

### MMS Client

Access is via a graphical user interface.

- Use MMS to build OpenVMS applications.
- Change the working (local and remote) directory.
- Fetch and open MMS description files.
- · Activate MMS description file generation.
- · Activate MMS builds on the remote system.
- Ability to execute arbitrary non-interactive DCL commands.
